Under the regulations set forth by the Internal Revenue Service you have the available to have funds withheld from your check on a pre-tax basis for deposit to a 403(b), 457 or ROTH IRA retirement annuity account.

If you are not interested in a 403(b),457 or a ROTH IRA annuity account mark the not interested box at the top, complete employee information, sign the bottom and date it.

EMPLOYEES UNDER REGULAR CONTRACT (NOT SUPPLEMENTAL)

EMPLOYEES UNDER SUPPLEMENTAL CONTRACT

Since supplemental contracts are paid in three (3) installments you can either have a percentage of your check withheld or a
fixed amount from each check.

SUBSTITUTE EMPLOYEES

Substitute employees who choose to have funds withheld from their checks for deposit into a 403(b) or 457 annuity accounts
must choose a percentage of their gross check for withholding. Inconsistent work schedules preclude a fixed amount for
withholding.
